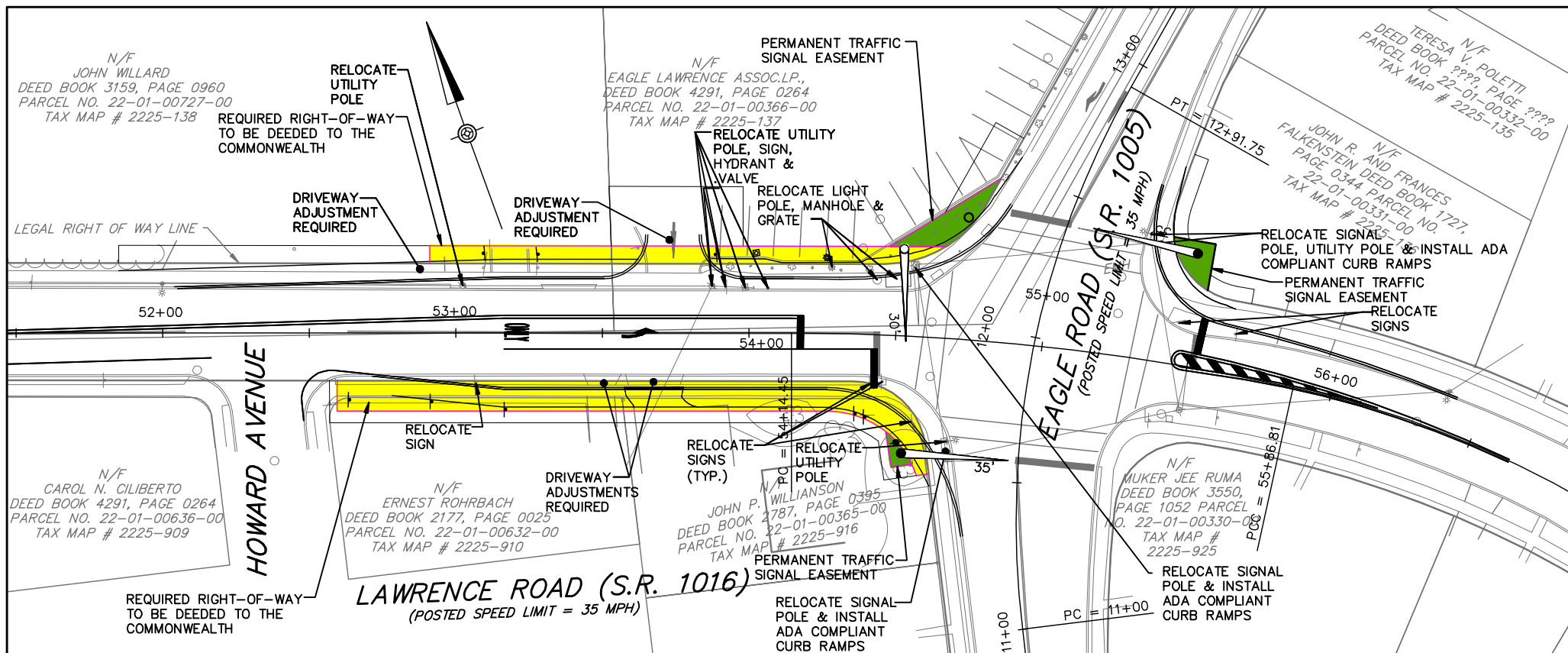


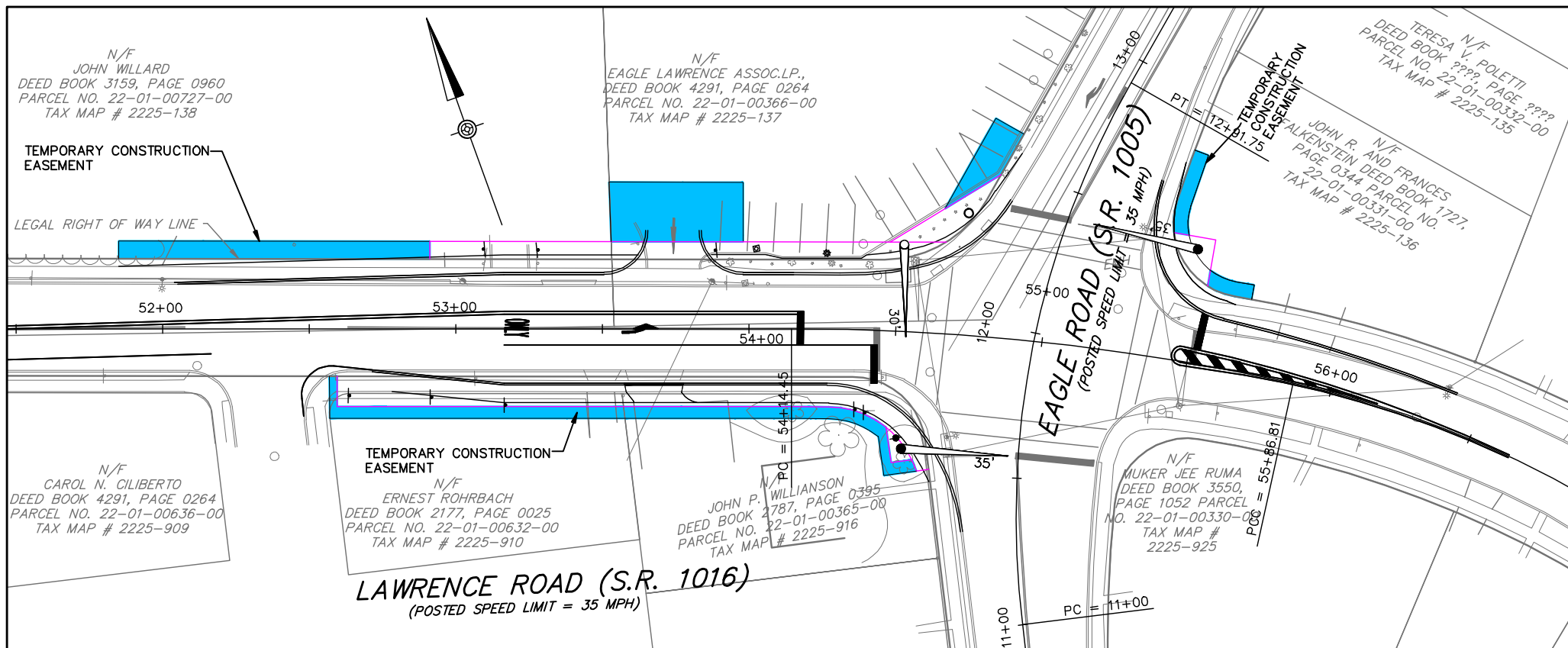

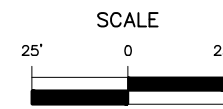
ALTERNATIVE A  
CONSTRUCTION OF A LEFT-TURN LANE ON THE EASTBOUND APPROACH OF LAWRENCE ROAD



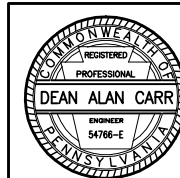
TEMPORARY CONSTRUCTION EASEMENT CONCEPT PLAN

ROAD AND DARBY ROAD

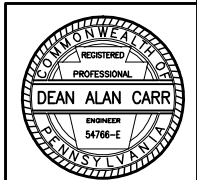
